#### **Terms & Conditions**

#### **Payment**

All invoices are due upon receipt. All payments received 30 days after the sent invoice date are subject to a 10% late fee of such invoice. This 10% late fee will be applied to the original balance every 15 days of no full payment. If no full payment is received within 45 days all work performed of such invoice will be removed from site until full payment is reached.

#### **Change Management**

Viciedo Web Development Inc. will not be held responsible for any activity requests outside of the scope of this agreement. Additional activity requirements must follow Viciedo Web Development change management procedures or must be identified as a separate project. Viciedo Web Development will gladly provide estimates for additional projects upon request.

### **Governing Law**

This Agreement shall be governed by and constructed in accordance with the laws of the State of Montana.

#### Severance

Should any portion of this Agreement be declared invalid and unenforceable, then such portion shall be deemed to be severed from this Agreement and shall not affect the remainder of this Agreement.

### **Termination**

This Agreement may be terminated by Customer upon notice in writing to Viciedo Web Development Inc. which notice shall be effective upon receipt by Viciedo Web Development Inc.
